SETTLEMENT ORDER

Karmen Lisaingo

WHEREAS:

For the Respondent:

- A. The appellant, Jack Goodwin, holds Guiding Territory Certificate 628G001 which overlaps with 57% of Wildlife Management Unit 6-28 ("MU 6-28").
- B. The 2022-2026 five-year allocation of Thinhorn Sheep to non-resident hunters in MU 6-28, relied on by the Director of Wildlife (the "Director") to inform 2022/2023 Tinhorn Sheep quota decisions, was zero.
- C. On July 4, 2022, the Director made the quota decision in respect of Guiding Territory Certificate 628G001. The appellant's 2022/23 quota of Thinhorn Sheep was zero.
- D. The appellant brought this appeal, File No. EAB-WIL-22-A011, of his 2022/23 quota of Thinhorn Sheep.

- E. Following additional review of available information, on July 15, 2024, the Director and Regional Manager amended the 2022-2026 five-year allocation of Thinhorn Sheep to non-resident hunters in MU 6-28 from zero to 4.2 (the "Amendment").
- F. The Amendment does not constrain but will inform quota decisions in MU 6-28 in subsequent licence years.
- G. The parties request that the Board make an order to fully resolve this appeal, File No. EAB-WIL-22-A011, without a hearing and by consent.

THE BOARD ORDERS as follows, pursuant to section 17(2) of the *Administrative Tribunals Act*, S.B.C. 2004, c. 45 that:

- 1. The appeal assigned EAB File No. EAB-WIL-22-A011 is dismissed.
- 2. Each party shall bear their costs of this appeal.
- 3. This Order may be endorsed by the parties in counterpart.
